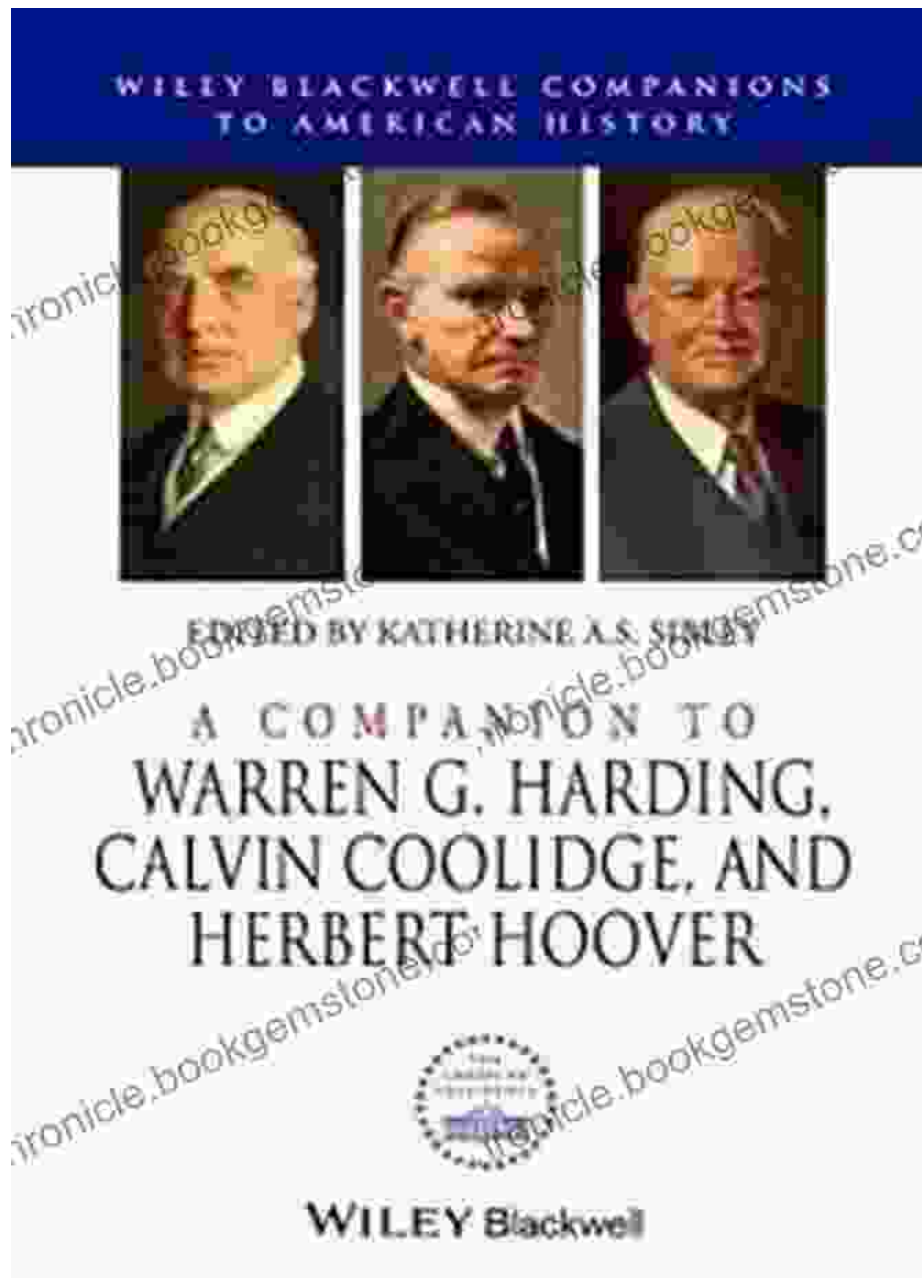
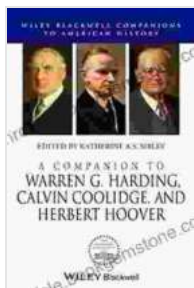

Warren Harding

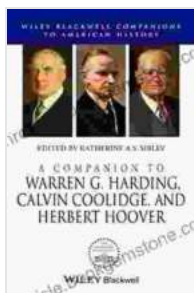
